DECISION

On the approval of the extension of the Certificate of Registration for Public Offering of Shares of DNSE Securities Joint Stock Company

THE CHAIRPERSON OF THE STATE SECURITIES COMMISSION

Pursuant to the Law on Securities No. 54/2019/QH14 as amended and supplemented by Law No. 56/2024/QH15;

Pursuant to Decree No. 155/2020/NĐ-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/NĐ-CP dated September 11, 2025;

Pursuant to Decision No. 686/QĐ-BTC dated February 28, 2025 of the Minister of Finance stipulating the functions, duties, powers and organizational structure of the State Securities Commission;

Pursuant to Circular No. 118/2020/TT-BTC dated December 31, 2020 of the Ministry of Finance guiding a number of contents on securities offering and issuance, public tender offers, share buybacks, public company registration, and revocation of public company status;

Pursuant to Official Letter No. 30/2026/CV-DNSE-TGD dated February 12, 2026 of DNSE Securities Joint Stock Company regarding the request for extension of the Certificate of Registration for Public Offering of Shares No. 488/GCN-UBCK dated December 15, 2025 issued by the Chairperson of the State Securities Commission;

At the proposal of the Head of the Securities Business Management Department;

DECISION

Article 1. To approve the extension of the Certificate of Registration for Public Offering of Shares for:

DNSE SECURITIES JOINT STOCK COMPANY

Head office: 6th Floor, Pax Sky Building, 63–65 Ngo Thi Nham Street, Hai Ba Trung Ward, Hanoi City.

License for Establishment and Operation No. 62/UBCK-GP issued by the Chairperson of the State Securities Commission on October 30, 2007

Charter capital: VND 3,426,000,000,000 (Three trillion four hundred twenty-six billion Vietnamese dong).

Enterprise Registration Certificate No. 0102459106 issued by the Hanoi Department of Finance, first registered on October 30, 2007, with the 14th amendment dated October 22, 2025.

Article 2. The Certificate of Registration for Public Offering of Shares No. 488/GCN-UBCK dated December 15, 2025 is extended until April 13, 2026. During the extension period, DNSE Securities Joint Stock Company must complete the share distribution.

Article 3. DNSE Securities Joint Stock Company must comply with Vietnamese law and regulations on securities and the securities market.

Article 4. This Decision takes effect from the date of signing.

Article 5.
