## DECISION

### On the change of listing registration

#### THE GENERAL DIRECTOR OF HO CHI MINH CITY STOCK EXCHANGE

*Pursuant to the Law on Securities dated November 26, 2019 and the Law amending and supplementing a number of articles of the Law on Securities, the Law on Accounting, the Law on Independent Audit, the Law on State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, and the Law on Handling of Administrative Violations dated November 29, 2024;*

*Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities dated November 26, 2019 and Decree No. 245/2025/ND-CP dated September 11, 2025 amending and supplementing a number of articles of Decree No. 155/2020/ND-CP;*

*Pursuant to Decision No. 02/QĐ-HĐTV dated June 30, 2021 of the Members' Council of Vietnam Exchange on the establishment of the Ho Chi Minh City Stock Exchange;*

*Pursuant to Decision No. 07/QĐ-HĐTV dated July 9, 2021 of the Members' Council of Vietnam Exchange promulgating the Charter of organization and operation of the Ho Chi Minh City Stock Exchange;*

*Pursuant to Decision No. 22/QĐ-HĐTV dated March 16, 2026 of the Members' Council of Vietnam Exchange promulgating the Regulation on listing and trading of listed securities;*

*Pursuant to the application dossier for change of listing registration of DNSE Securities Joint Stock Company;*

*At the proposal of the Director of Listing Management Division;*

### DECIDES:

**Article 1.** To approve the change of listing registration of **DNSE Securities Joint Stock Company** with the following details:

- Type of securities: **Common shares**
- Stock code: **DSE**

- Par value: VND 10,000 per share
- Number of shares before the change: **342,600,000 shares** (*Three hundred forty-two million six hundred thousand shares*)
- Number of additional listed shares: **85,649,806 shares** (*Eighty-five million six hundred forty-nine thousand eight hundred six shares*)
- Value of additional listed shares (at par value): **VND 856,498,060,000** (*Eight hundred fifty-six billion four hundred ninety-eight million sixty thousand dong*)
- Total number of shares after the change: **428,249,806 shares** (*Four hundred twenty-eight million two hundred forty-nine thousand eight hundred six shares*)
- Total listing value after the change (at par value): **VND 4,282,498,060,000** (*Four trillion two hundred eighty-two billion four hundred ninety-eight million sixty thousand dong*)
- Effective date of the change: **April 16, 2026**
- Reason for the change: Additional public offering of shares to existing shareholders

**Article 3.** The Director of Trading System Division, the Director of Market Information Division, the Director of Listing Management Division, and DNSE Securities Joint Stock Company shall be responsible for implementing this Decision.
